4 & 6 Dog Open Classes - (4 & 6 miles) (Open class constitutes any breed of dog)

4 & 6 All Register Siberian Classes (4 & 6 miles) (The Registered Siberian Class constitutes a team composed of purebred Siberian Huskies as recognized by the AKC/CKC. Proof of breed must be available if challenged)

3 Dog Sportsman (3 Miles)

2 Dog class (1.5 miles) is open to ALL dogs. No prize money paid trophies only.

Purse money will be divided by % of entries between the Open class & All Siberian Classes and will pay through 10th place. Trophies will be award to 1st - 3rd place in each class.
